In signing this contract, I agree to the following conditions:

- 1) The foster home shall provide the animal with adequate nutrition daily including fresh water, hay, pellets and fresh vegetables. The brand or type of pellet food must not be changed without prior approval of Hoppy Homes Rescue. Hoppy Homes Rescue will provide the foster with necessary pellets, hay, and litter, upon request.
- 2) All animals must be housed in a pen/cage big enough to provide adequate living space and exercise. Suitable pens/cages will be provided by Hoppy Homes Rescue, unless a pen/cage approved by Hoppy Homes Rescue is provided by the foster home.
- 3) The foster home shall maintain the animal's enclosure in an indoor residential location. The animal shall never be housed outdoors or in a shed/garage. If you take the animal outside he or she must be supervised in a fenced area or on a harness and leash for his or her own safety.
- 4) The foster home shall house the animal in such a way that it is inaccessible to other household pets without the direct supervision of an adult.
- 5) The primary guardian of the animal must be an adult 19 years of age or older. Supervision by a responsible adult shall be provided when a child or children are interacting with the animal.
- 6) The animal shall not be used for breeding. If a potential breeding partner is housed in your home you must notify Hoppy Homes Rescue of its presence.
- 7) Fostering of this animal does not give permanent ownership rights to the foster home. If a foster home wishes to adopt the animal, they must apply by completing an adoption application with Hoppy Homes Rescue. Adoption fees will apply.
- 8) The foster home will promptly notify Hoppy Homes Rescue if the animal shows any signs of illness, injury or change in behaviour. All veterinary appointments for the animal will be scheduled and booked by Hoppy Homes Rescue.
- 9) Hoppy Homes Rescue shall have the right to inspect the animal or its living conditions at any time with reasonable notice. Hoppy Homes may visit the home of the foster to ensure proper care is being provided. If proper care is not being provided, Hoppy Homes Rescue can remove the rabbit from the foster home's care immediately.
- 10) The foster home is not to abandon, give away, dispose of, turn over or relinquish custody of the animal to anyone else, except with prior approval by Hoppy Homes Rescue.
- 11) Hoppy Homes Rescue is not liable for any property or personal damage caused by the animal. For rabbits, you are responsible for rabbit-proofing all areas of the house to which the rabbit will have access and keeping the rabbit safe from harm.
- 12) The foster home further agrees that if, for any reason, the foster home does not wish to continue to foster this animal or if the foster home cannot abide by all the terms of the contract, the foster home will promptly return the animal to Hoppy Homes Rescue.
